These holds are typically initiated when a concerned party fills out an affidavit or delivers testimony to a judge regarding the potential mental illness of the person to be held, though these aren't requirements across all states.

About - 72 Hour Hold

First, anyone who is placed on a 72-hour hold has a right to request a hearing in front of a judge. The common misunderstanding, however, is that this hearing will occur within 72 hours. The 72 hours actual applies to the time frame the provider has to file the petition for involuntary commitment after taking the hold. And it does not include weekends and holidays.

A 72-hour hold under Nevada law - also called an emergency admission, Legal 2000 or L2K - is when a person with mental illness gets placed under medical observation, evaluation, and treatment for three days. 5150 Hold. Under California Welfare and Institutions Code (WIC) 5150, an individual can be placed (involuntarily) to a locked psychiatric facility, for an evaluation for up to 72 hours. Any peace officer or specific individuals authorized by a county government may place the hold. Three criteria apply - the individual is assessed to be: a danger to themselves, a danger to others, or "gravely disabled".
