When writing a paper, you will need to provide in-text citations (sometimes called parenthetical citations) for quotes, summaries, and to give credit for ideas. Every in-text citation must have a corresponding entry in the reference list, unless you are told otherwise (examples include personal communications and citing an entire website).

APA style citations are added in the body of a research paper or project and references are added to the last page. Citations, which are called in-text citations, are included when you're adding information from another individual's work into your own project.

Click at the end of the sentence or phrase that you want to cite, and then on the References tab, in the Citations & Bibliography group, click Insert Citations. From the list of citations under Insert Citation , select the citation you want to use.

The APA citation method is used mainly in papers written for social science disciplines. Such disciplines include sociology, psychology, economics and other behavior-oriented sciences. While the APA citation format is most common in these disciplines, it can be used in other ones as well.

Include an in-text citation when you refer to, summarize, paraphrase, or quote from another source. For every in-text citation in your paper, there must be a corresponding entry in your reference list. APA in-text citation style uses the author's last name and the year of publication, for example: (Field, 2005).

For example, the APA format calls for fewer abbreviations in the citations, but it places more emphasis on publication dates in the notations. The author and date are stated any time you use information from an outside source.

How to Make APA In-Text Citations and Examples

The APA reference page is a separate page at the end of your paper where all sources you cited in the main text are listed. The references are sorted alphabetically, double spaced, and formatted using a hanging indent of ½ inch. Use “References” as page heading and include a running head with your paper title and page number.
