The Controlled Drugs and Substances Act (French: Loi réglementant certaines drogues et autres substances) (the Act) is Canada's federal drug control statute. Passed in 1996 under Prime Minister Jean Chrétien's government, it repeals the Narcotic Control Act and Parts III and IV of the Food and Drugs Act, and establishes eight Schedules of controlled substances and two Classes of precursors.

All legislative documents related to controlled substances are contained in the Controlled Drugs and Substances Act, the Narcotic Control Regulations, Parts G and J of the Food and Drug Regulations, and the Benzodiazepines and Other Targeted Substances Regulations. Canadian legislation has been developed in compliance with the UN Single Convention on Narcotic Drugs, 1961 as amended by 1972 Protocol, and the UN Convention on Psychotropic Substances, 1971.

Requirements for Controlled Drugs and Drug Precursors for Research Purposes. Category 1 Drug Precursors and Schedule 1 Controlled Drugs are Controlled Substances which require formal licences from the Home Office, and, as such, are subject to strict controls to prevent their illicit use. It is illegal to hold, procure, produce, use, distribute or carry out research with such substances without a Home Office licence.
