The courses you need to take will depend on the type of insurance license you want to earn. The types of insurance covered in the education include accident and health, casualty and allied lines, life, motor vehicle physical damage appraiser, personal lines, title, and more.

How to Get a Pennsylvania (PA) Insurance License

As in many other states, prelicensing is required before you can take the exam for the Louisiana life or health insurance license. Specifically, you must take approved courses that amount to 20 hours of training for either life insurance or health insurance. For a combined lines life, accident and health license, 40 hours of coursework is needed.

Licenses are issued and renewed when candidates meet the requirements for licensure. License application and reporting services are provided by the National Insurance Producer Registry (NIPR) and Sircon powered by Vertafore.
