There is no EU law mandating the retention of communications data, following the ECJ's decision in 2014 that the Data Retention Directive (2006/24/EC) was invalid. In the UK, data retention is regulated under the Investigatory Powers Act 2016 (IPA) and includes powers for the Secretary of State to require a telecoms operator to retain relevant communications data in certain circumstances.
