An arrest may be made by a peace officer or by a private person (77-7-1, UCA). The key element of arrest is intent. A person, by law, is under arrest when another person gives notice, usually verbal, that he/she is taking such action, and then assumes custody. Physical restraint alone is not an arrest.

Unlawful or invalid arrests may have a variety of important legal consequences. For instance, it is generally recognized that a search of the person arrested and of the immediate premises is valid when "incident" to a lawful arrest. But if the arrest is unlawful, the search is also invalid, and can be barred from the criminal proceedings.
